

- The above results have been reviewed by the Audit Committee and approved by the Board of Directors in their meeting held on 12-08-2023. The statutory auditors of the Company performed Limited Review and have issued a Limited Review report on the above results
- 2. Interest of Rs. 1.53 Lacs against dealership deposits has not been provided for the current quarter.
- 3. Considering the operations of the company, only small number of employees, are employed and in view of this the requirements of Ind AS-19 Employee Benefits in respect of gratuity could not be compiled with. However provision for gratuity as required under Payment of Gratuity Act has been provided for and is being paid as and when the liability arises.
- The above mentioned income from operations are disclosed net of GST Collected.
- 5 The Company considering to exercise an option to avail concessional rate of tax under the provisions of Section 115BAA of the LT Act .
 Consequent to this despite profits for the period no provision for taxes is made considering the the unobsorbed Losses .
- 6. Deferred tax is not considered keeping in view the probability that the company may not earn taxable profits in the near future.
- Corresponding period figures have been regrouped / recasted wherever necessary to conform with those of aurrent period.

Limited Review Report - Financial Results

To the Board of Directors of Kabsons Industries Limited,

1. We have reviewed the accompanying Statement of Unaudited Financial Results of Kabsons Industries Limited ("the Company") for the quarter ended 30th June 2023 (the "statement") being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016.

This statement is the responsibility of the Company's Management and has been prepared and approved by the Board of Directors of a company in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting", prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India.
